SUBMIT documentation of immigration entry date into the U.S.: <ul style="list-style-type: none"> • For entry after age 26 - A date stamp on the 1-94 form; OR a date passport immigration stamp • For proof in status in U.S. until you turned age 26 - A letter from the U.S. Citizenship and Immigration Services (USCIS) indicating your entry date; OR a student visa form (1-20) or other valid U.S. passport visa stamp. A Resident Alien Card (Green Card) is not sufficient proof of date of entry. |
